## **SUPPLY AND DEMAND OF ENVIRONMENTAL INNOVATIONS: INSTITUTIONAL SUPPORT UNDER CONDITIONS OF INTRODUCTION OF THE BEST AVAILABLE TECHNOLOGIES**

**Summary:** In this paper the institutional support to create supply and demand for environmental innovations makes up the main focus of the author. The main role played by the Federal law № 219-FL is analyzed. By this law the process of the introduction of the best available technologies is regulated. The analysis of the mix of the environmental policy instruments by the authors reveals the need for some clarifications and completion on the basis of the OECD recommendations. This concerns the barriers to environmental innovations, the balancing of their supply and demand as main component of the Russia's renewed Innovation strategy and the modification of Russia's Energy strategy towards a low-carbon economy and the decrease of greenhouse gas emissions.
